Information We Collect

We may collect personal information including full name, email address, telephone number, date of birth, residential address, ZIP code, insurance-related information, financial-related information, and household information including income and dependents where applicable. We do not knowingly collect Social Security numbers or detailed medical records.

Automatically Collected Information

IP address, device and browser data, operating system, timestamps, referral URLs, and submission metadata may be collected automatically for security, fraud prevention, and quality assurance purposes.

Purpose of Collection

Marketing and lead generation, lead distribution, advertiser matching, fraud detection, compliance, analytics, and performance optimization.

Consent and Acknowledgment

By submitting information, users expressly consent to the collection, processing, and sharing of their data with multiple third-party advertisers. Digital Hub does not initiate outbound calls, SMS, or prerecorded messages. Email communications, where applicable, are sent by third-party partners.

Data Sharing

Data may be shared with licensed insurance agents, brokers, carriers, financial service providers, lenders, and promotional partners. Lead distribution may occur through real-time technologies including ping-post methodologies. Data is not shared with third-party call centers.

Technologies

Digital Hub uses fraud detection and call tracking technologies where applicable. No behavioral retargeting or session recording tools are used.

Data Retention

Personal data is retained only as long as necessary for operational, legal, compliance, and contractual purposes, after which it is securely deleted.
